We don't expect to eliminate heart disease through bypass surgery.

We don't aspire to end cancer by perfecting chemotherapy.

And the disease of addiction will always persist without prevention.

What are the first steps if heroin addiction and overdose are the last? Most addicted people had layers of risk factors—
inherited and acquired—before they ever picked up a pill or a needle. Addiction is the complex result of genes, trauma
and other things beyond one's control, combined with unhealthy coping habits. The news stories skip the beginning,
which occurred without fanfare.

Developing the disease is a process: preventing it is, as well. Prevention activities raise anxiety about the consequences of
alcohol, tobacco, other drug use and gambling—but just the right amount! Too much and we're simply scaring. Then,
more importantly, concrete skills are given: social, emotional and life skills, to empower and reassure. We don't ever leave
anyone afraid.

The solution to the opioid epidemic is multi-faceted. And its foundation is prevention. Not what we guess prevention to
be, or which quick measure we hope it is. But research-backed, long-term programming targeted to age, culture and level
of risk. The magic happens quietly: thank you for playing a part.




INCOME 2014/2015
