FSA

Lancaster's Family Services Advocate (FSA), Karlee Shambaugh, has been conducting parenting groups in Lancaster County Prison (LCP). A total of 52 parents that are incarcerated graduated from the program. Additionally, in partnership with LCP, Karlee facilitated 43 "contact visits" between children and their incarcerated parent. A "contact visit" is a visit between the child and parent without glass partitions; they occur in an open visiting room allowing children to play games with their parent, read with them, and hug them.

Lebanon - NEW Office


Compass Mark's Lebanon office has moved to a new location! The new address of 625 South 5th Avenue allows for space to conduct trainings for Compass Mark partners and community members.

Chester County Grant

Compass Mark was awarded a \$250,000 grant from the Pennsylvania Commission on Crime and Delinquency (PCCD) to be spent over two years to enhance our school-based programs in Chester County. Compass Mark will work collaboratively with two Chester County school districts to provide comprehensive prevention programs over multiple grades, and over multiple years. The goal is to provide a foundation where we reach students consistently and repeatedly throughout their entire school career. Research demonstrates that the more hours a student is provided evidence-based prevention curriculum, the greater the outcomes.

I have seen the impact that our consistency and persistence has had in our program implementation. I can see how we are making our mark in Chester County schools. I am excited to see Chester County expand in the future by serving more schools in our districts and providing more services and programs by building this trust and reliability within the districts.

TRAINING & PROFESSIONAL DEVELOPMENT

STUDENT ASSISTANCE PROGRAM (SAP)

Compass Mark is a Commonwealth-Approved Trainer for the Student Assistance Program (SAP). SAP is designed to assist school personnel in identifying substance use and mental health issues that pose barriers to a student's success, and to implement a plan to help the student overcome those barriers. In August 2024, Compass Mark debuted our state's new, two-day Student Assistance Program (SAP) Team training. SAP is a process in schools which identifies and removes barriers to a student's success, whether those barriers are academic, social, attendance, substance use, mental health, or other issues.

The new training design came after two years of collaboration between PNSAS (PA Network for Student Assistance Services) and the SAP Team Trainers. Compass Mark was one of six training agencies across the Commonwealth to implement this pilot in January, 2024, and the first training agency to provide the two-day model to school districts.

The Training & Professional Development
Department provides a range of training
services to school and agency staff. Topics
covered have included fetal alcohol spectrum
disorders, gambling and youth gaming,
substance use, and mental health trends
among youth. Compass Mark also provides
supportive workshops for SAP Teams to ensure
they can effectively support students while
operating with fidelity to the SAP model.


